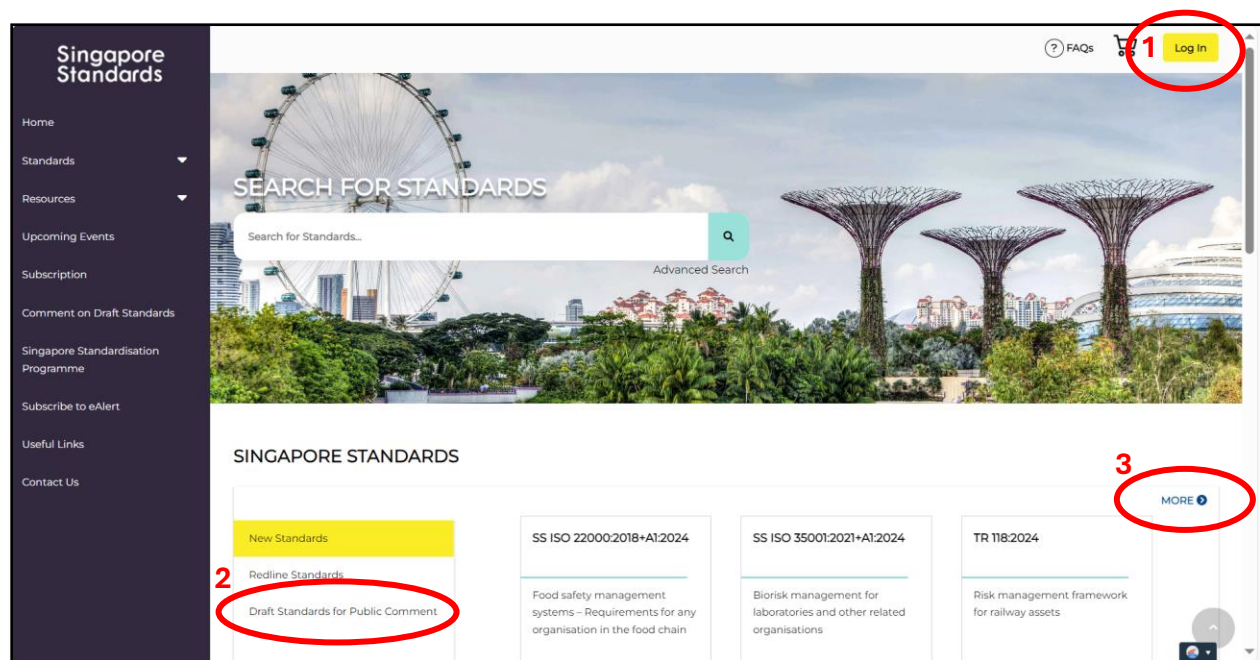


Step-by-step guide to provide comments to the Singapore Standards on Management systems for outdoor adventure education (OAE) activities.

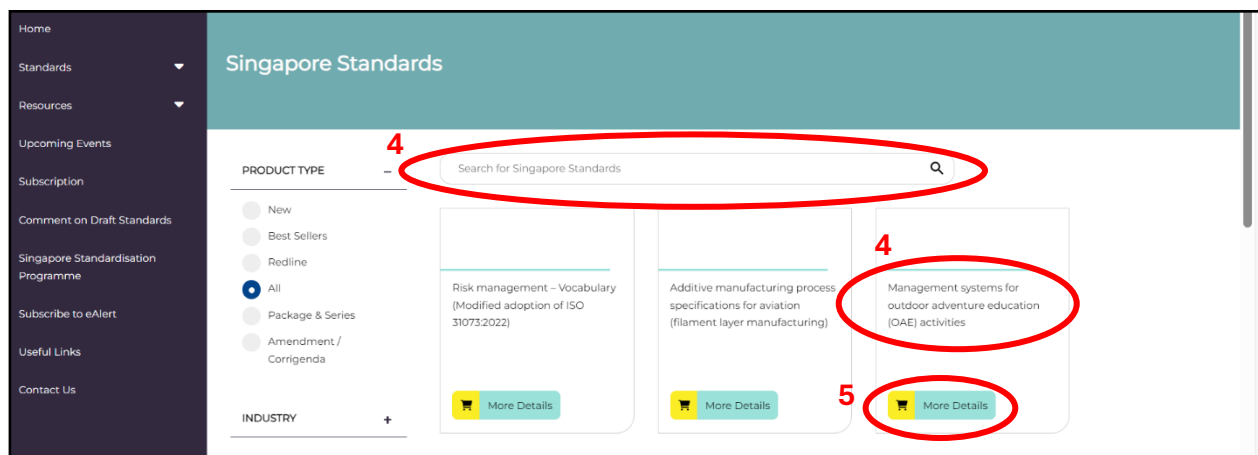
